

TERMS & CONDITIONS

VRC Punters Club – 2024/2025 Racing Season



1. The Promoter is Victoria Racing Club Limited ACN 119 214 078, 448 Epsom Rd, Flemington, VIC, 3031. **(Promotor)**.
2. Information regarding how to enter and details of prizes forms part of these conditions of entry. Entry into this promotion is deemed to be acceptance of these conditions of entry.
3. Entry is open only to residents of Australia over 18 years of age attend during the promotion period including VRC Members and their Guests and Public Patrons **(Eligible Entrant)**.
4. The promotion commences at the jump of Race 3 for a 9 race card and the jump of race 4 for a 10 race card and closes after the 'correct weight' of the last race at Flemington on each of the following race days (each, a **Promotion Period**):

5. To enter the VRC Punters Club Promotion (**Promotion**), an Eligible Entrant must pay a fee of \$10.00 (**Entry Fee**), provide your full name and phone number (for Guests or Public Patrons) or provide their member number (VRC Members) to the Promoter prior to the commencement of each Promotion Period. There will be two registration desks during each Promotion Period (The Atrium and Saintly Place). Eligible Entrants are limited to a maximum of three entries per person per each Promotion Period.
6. Once an Eligible Entrant has been registered into the Promotion, they will be given a ticket that recognises their involvement in the Promotion and can be used to redeem prize money (if any) at the end of each Promotion Period.
7. Once an Eligible Entrant has been registered into the Promotion, they will be given a ticket that recognises their involvement in the Promotion and can be used to redeem prize money (if any) at the end of each Promotion Period.
8. All Entry Fees will be totalled and used to form the basis of the Promotion (**Entry Pool**). The Promoter will 'top up' the Entry Pool by \$500 at the beginning of each Promotion Period.
9. The Promoter will throughout each Promotion Period, in its absolute discretion, place one or more bets, using the total value of the Entry Pool of each team, on races held during the day at Flemington Racecourse or at another racecourse during each Promotion Period. The Promoter can reuse any winnings from a bet, and allocate as part of any future bets.
10. At the end of each Promotion Period, the Entry Pool (if any) will be equally distributed to all Eligible Entrants in the form of cash payments. To the extent that the calculated amount payable to each Eligible Entrant is not an exact amount, the Promoter will round the amount up to the nearest \$1 increment (eg. \$13.45 will be rounded up to \$14.00). Patrons must present their ticket and sign it to collect their winnings, this signing of the Eligible Entrant's entry ticket will be proof of collection of winnings for the Promoter. Any winning funds will be distributed from 10 minutes after "correct weight" is official after the last race at Flemington on each day of the Promotion Period. Members who leave earlier than this must contact VRC staff on the day and any winnings will be distributed as cash-on-card credits on their membership card prior to the next race meeting held at Flemington. Member's Guests and Public Patrons must stay until after the last race to collect their winnings. Any unclaimed winnings from Member's Guest and Public Patrons will be donated to a charity of VRC's choice.
11. The Promoter reserves the right to alter these terms and conditions without notice. The Promoter's decision is final and no correspondence will be entered into.
12. The Promoter may, in its absolute discretion, decide to not run the Promotion any one or more of the race days listed during the overall Promotion Period.
13. The Promoter (including employees, contractors, agents and representatives) will not be liable for any loss caused by an error when placing bets in the relevant system as determined by the Promoter from time-to-time.
14. The Promoter will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense, damage, personal injury or death which is suffered or sustained (whether or not arising from any person's negligence) in connection with this promotion, except for any liability which cannot be excluded by law (in which case that liability is limited to the minimum allowable by law). Eligible Entrants acknowledge and agree that they enter into this promotion at their own risk.
15. The Promoter will collect personal information from Eligible Entrants in order to facilitate the Promotion. Eligible Entrants personal information may also be provided to third parties (including prize suppliers) for the purpose of administering this Promotion. If the information requested is not provided, you may not be eligible to participate in the Promotion.

VRC Punters Plus

1. Public Patrons are able to enter the Promotion through purchasing the VRC Punters Plus via the Ticketmaster website. The VRC Punters Plus includes general admission entry into Flemington Racecourse on the purchased raceday, entry into the Punters Club for the purchased raceday, a racebook and a \$25.00 food and beverage voucher.
2. Any Public Patron who enters the Promotion through purchasing the VRC Punters Plus (if applicable) must follow the above VRC Punters Club terms and conditions including the collection of tickets prior to Race 4. Public Patrons who purchase the VRC Punters Plus and fail to collect their entry ticket prior to Race 4 or fail to comply with these Terms and Conditions will forfeit their entry into the Promotion and the \$10 Entry Fee will be donated to a VRC charity partner at the Promoter's discretion. Where multiple VRC Punters Plus have been purchased in the same transaction, only the named ticket purchaser will be able to collect the entry tickets into the Promotion on behalf of all the Eligible Entrants.
3. Upon registering at the Punters Club, the VRC Punters Plus ticketholder will receive their racebook.
4. Any food and beverage voucher (**Voucher**) that is received through the purchase of a VRC Punters Plus (if applicable) will be subject to the following terms:
 - The Voucher is valid only for use at Flemington Racecourse on the ticketed race day.
 - The Voucher is valid for the total value of \$25.00.
 - The Voucher is accessed through the general admission digital ticket issued through Ticketmaster when purchasing the VRC Punters Club Value Pack.
 - To redeem the Voucher, the Ticketmaster digital ticket QR code is to be scanned at point of purchase.
 - If total purchase is less than the Voucher amount, no change will be given. The Voucher is not redeemable for cash.
 - Cash can be used for any amount of a transaction made with the Voucher that exceeds the Voucher amount.
 - The Voucher is non-refundable, non-transferrable and only redeemable in public areas at permanent food and beverage outlets.
